Sub: Launching of online "Licensing System for District Authorities (LSDA)" for the use of all the District Authorities for granting online licenses w.e.f 15th February 2017 under Explosives Rules, 2008 & Ammonium Nitrate Rules, 2012 - Reg.

Sir(s),

The online "Licensing System for District Authorities (LSDA)" for the use of all the District Authorities for granting the following licenses under Explosives Rules, 2008 & Ammonium Nitrate Rules, 2012 has been launched w.e.f **15th February 2017**.

Under Explosives Rules, 2008 (ER, 2008):

- License in Form LE-3 to possess Explosives for agricultural purpose or use in small quarry.
- License in Form LE-4 to possess and transport of Explosives in tractor compressor for use in well sinking.

Under Ammonium Nitrate Rules, 2012 (ANR, 2012):

- License in Form P-3 to Possess for sale of Ammonium Nitrate from a store house not exceeding 30 MT.
- License in Form P-3 to Possess for use of Ammonium Nitrate for agricultural purpose from a store house.
- License in Form P-4 to transport Ammonium Nitrate for licenses granted by District Authority for possession for sale of Ammonium Nitrate.

All License Holders under Explosives Rules, 2008 & Ammonium Nitrate Rules, 2012 granted by PESO are requested to make note of the followings:

- 1) From **1st May 2017** only those licenses which are issued by District Authorities through the online "**Licensing System for District Authorities (LSDA)**" will be enabled to carry out online transactions such as raising online indents, purchase, sale, transport & use of
 - Explosives through PESO's online "Explosives Return System (ERS)"
 - Ammonium Nitrate through PESO's online "Ammonium Nitrate Return System (ANRS)"

- 2) Hence, may advise all the DM's license holders to whom you are supplying Explosives/Ammonium Nitrate to approach the respective DM with following documents to get their manual license re-issued (Backlog Entry) through on line system (LSDA).
 - a) Filled and signed **INPUT FORM - (Explosives)** or **INPUT FORM – (Ammonium Nitrate)** available in the login page of ERS & ANRS.
 - b) Original copy of manually issued DM's license for surrender to DM's Office.
 - c) Five copies of color photographs of the Occupier signed by him on the face of the photographs for affixing on the online granted license.

Subject: Launching of online "Licensing System for District Authorities" (LSDA) under the Explosives Rules, 2008 and Ammonium Nitrate Rules, 2012 for the use of all the District Authorities-regarding.

Sir,

I am directed to say that Petroleum and Explosives Safety Organisation (PESO), Nagpur, a Subordinate Office under this Department, is administering the Explosives Act, 1884 and various rules framed thereunder. PESO has made GO-LIVE the online "Licensing System for District Authorities (LSDA)" for the use of all District Authorities in the country for granting the following licences:

Under the Explosives Rules, 2008 (ER, 2008):

- b. Licence in Form LE-3 to possess for use of Explosives for agricultural purpose or in small quarry.
- c. Licence in Form LE-4 to possess and transport Explosives in tractor compressor for use in well sinking.

Under the Ammonium Nitrate Rules, 2012 (ANR, 2012):

- d. Licence in Form P-3 to possess for sale of Ammonium Nitrate from a store house not exceeding 30 MT.
- e. Licence in Form P-3 to possess for use of Ammonium Nitrate for agricultural purpose from a store house.
- f. Licence in Form P-4 to transport Ammonium Nitrate for licences granted by District Authority for possession for sale.

2. The LSDA login page link for District Authority is available on PESO's website: <http://peso.gov.in/Index.aspx> as "LSDA (Licensing System for District Authorities)". A brief note on LSDA is enclosed at **Annexure I**. The user IDs & Passwords of the DMs of your State/UT to operate LSDA is enclosed herewith at **Annexure II**. Any query/clarification may be mailed to support.lsd@explosives.gov.in from DM's official mail id.

3. All the existing licences under **ER, 2008** & **ANR, 2012** granted manually are to be re-issued (Backlog Entry) through LSDA by the respective District Authority on or before **30th April, 2017**. From 1st May, 2017, only those licences issued through LSDA will be enabled to carry out online transactions viz., raising online indent, purchase, sale, transport, use through the

- ✓ PESO's online "Explosives Return System (ERS)"
- ✓ PESO's online "Ammonium Nitrate Return System (ANRS)".

4. To make the process of re-issue (Backlog Entry) of existing manual licences issued till date easier, the **INPUT FORM - (Explosives)** & **INPUT FORM - (Ammonium Nitrate)** available in the login page of LSDA shall be filled and submitted by the licensee to concerned District Authority, along with a copy of licence. The said INPUT Forms are also made available at PESO's website <http://peso.gov.in>
5. Henceforth, all District Authorities shall issue fresh licence under **ER, 2008** & **ANR, 2012** through LSDA, only.
6. Licences which are issued/re-issued through LSDA shall be renewed through LSDA only.
7. It is requested that all the DMs of your State/UT may please be advised to make use of Online LSDA for granting the licence under the Explosives Rules, 2008 & Ammonium Nitrate Rules, 2012.
